Cllr Mrs Stanney said there had been no applications for the post of Clerk following the advertisement and she had asked Mrs Roxana Brammer of R B Consultants to take the meeting. After discussion, it was proposed by Cllr Mrs Stanney, seconded by Cllr Budd and agreed that R B Consultants be invited to provide the service of the clerk. This was accepted under the following terms:

R B Consultants to charge a special fee of an hourly rate equivalent to the NALC rate LC1 benchmark, currently £8.14 /hour, with the usual increment from 1 April 2007, plus reimbursable expenses. An invoice would be rendered on a bi-monthly basis, for payment at each parish council meeting. The agreement to run until 31 March 2008, with the possibility of an annual renewal after that date.
